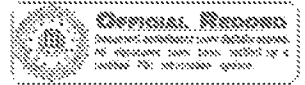

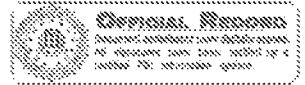

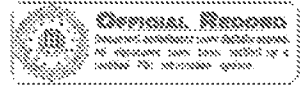

SA [redacted] told LANDEROS that his group and website may draw people that are intent on doing harm and thus giving his group a bad name and reputation. SA [redacted] asked LANDEROS if he would contact the FBI if individuals came to his group who he thought were a threat. He said "Yes. Thank you for coming. Goodbye." He then closed the door.

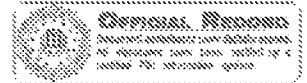

CHARLIE used to be a caring smart person. [redacted]

[redacted] CHARLIE was a helicopter mechanic in the military. After leaving the military, CHARLIE worked for Helicopter Transport Service. He worked in Ecuador for four months and then home for four weeks. He was making really good money and then all of the sudden he quit and said he was going back to school.

That is about the time (approximately two years ago) when his demeanor changed and he started acting weird. He got obsessed with the University of Oregon and their treatment of minorities. He started talking about how he hates Nazis and is obsessed with hating them. [redacted] once asked CHARLIE why he was so upset with U of O even though he was a student there. He responded that he could not afford to go there and rambled on about their treatment of minorities.

[redacted] he was non-binary (neither male nor female) to which [redacted] told CHARLIE to stop discussing things like that. [redacted] is aware CHARLIE started a group to teach people how to shoot guns. [redacted] saw his video on the web site where he is shooting. CHARLIE told [redacted] he has a gun [redacted]

CHARLIE does not drive anymore and is living with [redacted] does not know of any drug use or diagnosed mental health issues. [redacted] has told people that [redacted] (CHARLIE) is crazy and [redacted] would not be surprised if [redacted] saw his face on the evening news. When asked if CHARLIE was violent or capable of committing a violent act, [redacted] hesitated and said, "I'm not sure but it wouldn't surprise me."
